**Information**

Under state law, the ownership and valuation of all real estate and personal property subject to taxation will be fixed as of April 1. For this tax bill, the date is 4-1-23. If you have sold your real estate since April 1, it is your obligation to forward this bill to the current property owner.

Without state aid to education, state revenue sharing and state reimbursement for the Maine resident homestead property tax exemption, your tax bill would have been 35.68% higher. Total Bonded Indebtedness as of 08/18/2023: \$29,506,462.
